**PORTABLE SIGN:** Any sign which is not permanently affixed to a building, structure, or the ground or which is attached to a vehicle, or on its own trailer, wheels, or otherwise is designed or intended to be transported from one place to another. It is characteristic of a portable sign that the space provided for advertising messages may be changed at will by the replacement of lettering or symbols. May not be erected for more the 30 consecutive days per permit. Four (4) permits for a particular property may be issued per 12 month period.

**TEMPORARY SIGN:** Any sign not constructed or intended for long term use. This excludes window signs and portable signs. May not be erected for more the 30 consecutive days per permit. Six (6) permits for a particular property may be issued per 12 month period.
